- ii) To promote research into ornithology and to publish the useful results of such study.
- iii) To support and encourage the preservation and conservation of wild birds and places of ornithological interest.

The main activities of the Hampshire Ornithological Society are:

To promote and record the study of bird life in Hampshire and to publish the results in the annual Bird Report.

To use these results to encourage and support the conservation of wild birds and their habitats within the county.

To foster a wider interest in the recording and preservation of Hampshire bird life by organising a programme of indoor and outdoor meetings, by publishing a quarterly magazine and other forms of publicity.

## Achievements and performance

Summary of the main achievements of the charity during the year

Chairman's Report sent to Members prior to AGM in March 2018

"In my first report to you as Chairman, I am pleased to say that the Society is in good shape and that its trustees have lots of ideas for the future. Indeed, we have spent time discussing the things we'd like to do over the next five years. This process has been aided by the arrival of Andy Broadhurst and Marcus Ward into their respective roles as chairs of the sub-committees. Our work on both membership and bird research has increased. We have lots of new ideas and if we lack anything it is the time to convert all of our ideas into action – but that has to be better than having all action and no ideas!

One great idea was from Caroline French who suggested that HOS do more to help people to learn about birds, whether as a relative newcomer or someone who has watched birds all of their life. The result has been a series of "Birding Basics" workshops to offer training to members and non-members alike (1). The non-members are converted into members by way of a higher charge for the workshops which includes automatic enrolment in HOS. To date three workshops have been organised and all have been sell-out events – and more are planned.

HOS has been active on many other levels too – making representations on planning applications that negatively impact on birds, liaising with Hampshire County Council's staff, and maintaining a strong dialogue with conservation professionals in the RSPB and HIWWT (2).

Three years ago we established a Grants Programme aimed at significant projects that make positive changes for Hampshire's birds or our understanding of their lives. In 2016 we gave £6000 to three projects, and in 2017 we planned to do the same. In fact, the quality of the applications was so high that we decided to increase our funding to £9000 (3). We cannot do this for ever, but it is the belief of your trustees that we need to act now rather than simply watch the money losing value in the bank. We still have funds to use in future years, and we are already thinking of ways to find co-funders who will make our money go further.

For most members, the Hampshire Bird Report is the main thing that they associate with us, and thanks to the hard work of Mike Chalmers and his team of writers and photographers, the quality gets better every year (4). The bird data that we collect from many sources now goes into a new online database called Cobra 2, and I am grateful to John Clark and Alan Cox for making sure that the introduction of this system was successful.

In closing I would like to thank everyone who has helped to make the HOS machine work so smoothly. Running a successful Society is not rocket science, you just need good people – and we are lucky to have plenty. Looking ahead I am keen that we involve more members in our activities – so if you think you can help HOS in any way then please get in touch with me, particularly if you have never helped us before. New blood tends to arrive with new ideas, and new ideas usually result in a better end product. So all ideas are welcome! Thank you for your support.
